Nebraska Voters Strongly Support Embryonic Research

OMAHA, (Neb) The Nebraska Coalition for Lifesaving Cures released the results of a poll indicating that a majority of Nebraskans support embryonic stem cell research overall, and specifically they support it being conducted in Nebraska, by a ratio of nearly three-to-one over strong opposition, or, 69 percent in favor and 25 percent opposed.

Heartfelt hope: Receiver of novel embryonic stem-cell therapy doing 'well'

PARIS, Jan 16 - A woman treated with a revolutionary embryonic stem-cell therapy for severe heart failure is doing well three months after the operation, her cardiologist reported today. The patient, 68 at the time of the procedure last October, was given juvenile heart cells that had been grown in the lab from human precursor cells, Philippe Menasche of the Georges-Pompidou European Hospital in Paris told AFP.

ANN ARBOR, Mich. - University of Michigan alumna Brooke Kendrick and her husband Stephen were ready to start a family. tested for the genetic defect, and to implant only disease-free ones.

Stem cell clinic faces fraud allegations over dubious stem cell trial for MS

Broeska, who apparently patients referred to as "Dr. Doug", not only did not have an MD, but also lacked a Ph.D. In fact, Broeska's previous experience was in lumber, which is long way from stem cells or MS or really anything medical or scientific.

Israel's BrainStorm says stem cell drug benefits most patients in ALS trial

(Reuters) - Israel's BrainStorm Cell Therapeutics said final results from a clinical trial of its adult stem cell treatment in amyotrophic lateral sclerosis (ALS) were positive, with most patients showing a slowing in the disease's progression. According to the ALS Association, 5,600 people in the United States are diagnosed each year with the neurodegenerative disease, which has severely disabled British physicist Stephen Hawking.
